Planning Commission hears day care center appeal, new office building plans

On June 26, the Planning Commission heard presentations on temporary use permits and a day care facility, and permit applications for a new office building and a commercial

Temporary Use Permit ordinance initiation: At this time, the city has no formal process for granting permits for single or infrequent events on non-residential properties. Grand opening celebrations and other special events have heretofore been held at the owners' own risk. City staff had requested that the Planning Commission initiate a formal process to draft an ordinance to provide for temporary use permits (TUP).

The Commission voted to initiate the process. A draft of the ordinance will be presented by staff at a future Commission meeting.

1806 W. Campbell Ave.: Starbright School is a preschool and daycare center, which began in this location in 1995 under a different name. In 2013, the school had been granted a modification to their existing conditional use permit (CUP), to install retractable seating in their large multipurpose room. In March 2018, an event coordinator not attached to the school applied for a liquor license for an event at the school. This alerted city staff to the fact that the school was hiring out the multipurpose room for private events, and remaining open after permitted hours. These are violations of the CUP. Since that time, city staff had been working with an attorney representing Starbright School to correct the land-use violations.

In the past few months, misleading information about this process had circulated among parents and staff at the school. The presentation at this Planning meeting Commission designed to introduce the issue, and provide an opportunity for members of the public to express opinions.

Several members of the public spoke in favor of allowing the school to continue allowing private events. These events range in type from business seminars to performing arts plays and recitals. Members of performing arts groups praised the venue as being unique in the area and well-

suited to many different kinds of performance. Some parents of Starbright students expressed awareness that the school depends on the income from these events to help pay for the facility, and were in support of this action.

presentation from city staff included information that the events are held mostly outside of the daycare hours, and that the children at the school are separated at all times from the events and event personnel. City staff did not recommend revocation of the school's permits, but only to place this issue on the Commission's agenda.

The Commission voted to continue this item, to a future formal hearing.

95 E. Hamilton Ave.: In 2016, the owner of this property had been granted a permit to construct a professional office building on this site. However, the submitted plans were not entirely in compliance with city requirements, and the permit expired. The owner had recently submitted a new permit application with revised plans.

The new plans include several modifications to the parking area, with protective devices for the existing trees, and more landscaping overall. Two standard parking spaces would be converted for up to eight motorcycles or scooters.

The Commission approved this permit application.

577 Salmar Ave.: This building, originally a health spa, was converted in 1996 to professional offices. California South Bay University and Triton institute had applied to open two commercial adult schools in part of the building.

Part of the application is a request for a modified parking requirement. There are 52 actual parking spaces on the property. Regulations under the city's General Plan would require four additional spaces to accommodate the schools. The modification request had been made based on several factors, including staggered class times, and close access to public transportation. Additionally, one of the other businesses in the building does not use all of its assigned parking.

The Commission approved applications, with the modified parking requirements.

Campbell will see through our youths' eyes

Capture Campbell is a photo contest for Campbell's youth facilitated by Campbell's Civic Improvement Commission (CIC). Entrants must be 18 years of age or younger and live or attend school in Campbell. Photo submissions will be accepted electronically until September 30, 2018.

With this photography program, the CIC's hopes to inspire Campbell's youth to show residents what Campbell looks like through their eyes.

Entries will be placed into three age groups: 10 and under, 11-14, and 15-18. Each youth photographer may submit 1-3 photos, but only one photo may be submitted into each of the three contest categories: Outdoor/ nature (i.e. scenery, trees, flowers, sunrise), Campbell life (capture things that residents do

- read, bike, shop, laugh, play, dance), and architecture (i.e. buildings or details of a home or building, bricks, bridges).

Contest judging will be completed by panel selection comprised of four to five local photography professionals, October 1-8, 2018. There will not be any public voting during the contest. Judging will be based on the following criteria:

Impact and Creativity: evoking feeling, imagination, and conveying an idea

Style and Composition: use of light and other elements to capture attention

Technical Excellence: exposure, sharpness, color balance, lighting, and posing

Presentation and Theme: showcasing your image consistent with the theme

one-hundred (\$100) first place cash prize will be awarded in each of the three categories. Finalists will be notified and invited to the Civic Improvement Commission meeting on October 11, 2018.

Contest rules requirements are clear. 1. All photos must be taken in the city of Campbell. 2. All photos must be submitted in .JPEG digital format with a minimum resolution of 300 dpi, and must be a single photo (no collages). 3. All photos must be taken in a public place. 4. Entries must include name, email address, location of photo, and device used. 5. Winners limited to one first-place prize per person.

Spamalot - King Arthur is alive and well!

If you want to get away from your daily life or escape from boredom, then head on down to the Saratoga Civic Theater where West Valley Light Opera's production of Spamalot will be playing on weekends through July 21.

The plot line is a series of short stories about King Arthur and his Knights of the Round Table - all told with a tongue in cheek style of writing. It is not taken very seriously and historians would probably frown at the writing, but it sure is a lot of fun.

Director Geoffrey Ward has assembled an outstanding cast of male actors and one fabulous female. In the leading role of Arthur is South Bay newcomer Scott De Lorenzo. He has great stage presence and a clear, distinct speaking voice - every word is understandable, even with his British accent. He also sings well and shows his dancing skills in the musical numbers. He has great comedic timing with his lines and gets his laughs when needed. Author and lyricist Eric Idol would be proud of him. Matching him step by step is Karyn Rondeau.

Ms. Rondeau is quite a singer with an unlimited vocal range, which she fully demonstrates in her second act show stopping "Whatever Happened to My Part?" Peter Woodhouse as Sir Robin also scores highly with his dancing and singing skills with "You Won't Succeed on Broadway." The other knights (Tyler Savin, Ali Pasha Croes and Andrew Kracht) are very strong in supporting roles and each have a moment to shine.

There are some actors in featured roles which are also stand outs. Kevin Spratt early with "I'm Not Dead Yet" and then comes back in the second act as Herbert, who is the Prince locked in a castle whom Lancelot must rescue. He is a superb character actor and a real winner with the audience.

John Brewer, as the historian and then Herbert's father, also deserves high marks for his two varied characterizations. With his wigs and costumes, most audience members were unaware that it was the same person

The choreography, which is abundant, deserves mention. Lisa Callaghan, a veteran of West Valley, has done a nice job of being very inventive of the many musical dance numbers; each is unique and has a flair all its own. The girls are always good and the men are getting in step with them. That is a special challenge

Frank Finckle

One hundred and forty-two years ago, on June 25, 1876, a battle that would come to be known as "Custer's Last Stand" was fought. All of the officers and men in the five companies under the direct command of George Armstrong Custer were killed by the Lakota and Cheyenne Native Americans opposing them. Or were they all killed?

Over the course of the following seventy years, at least 125 men and women are documented as claiming to be a survivor of the engagement on the United States side. Most people will recall that Lt. Col. Custer divided his command into three parts: one under Captain Benteen, one under Major Reno, and one under the direct command of Custer himself. Only Custer's immediate command was wiped out. There were, indeed, many survivors from the columns under Reno and Benteen that maintained a defensive position on Reno Hill until they were relieved by the troops under Generals Terry and Gibbon.

The most accepted version has the last soldier to see Custer and his troopers alive as trumpeter Giovanni Martini. He carried the famous "Be quick... Bring packs" message intended for Capt. Benteen. Martini was an Italian immigrant with only rudimentary English language skills who left the Custer column before it engaged the Native Americans. It might have been felt that Martini might not have been able to communicate the urgency of the situation, which led Lt. William Cooke to hastily write the dispatch and give it to Martini. Previously, just as Custer decided to turn to the right after leaving the Lone teepee, Sergeant Daniel A. Kanipe was given a message to deliver to Maj. Reno in order to encourage his efforts in the valley.

There are some accounts by Native Americans of crazed horses bolting and soldiers fleeing away from the battle, but all were reported to have been killed. The only person accepted as a survivor of the Custer column once fighting had begun was Curly, the young Crow Native American scout. He had been one of the many Native American scouts assigned to Custer's column. Perhaps because of his youth, or as a final effort to get a message to Capt. Benteen, Curly was sent out from the column. Curly described riding a short distance from the column and then stopping and turning around to actually see Custer's men engaged in intense fighting. Curly never participated in the combat.

In 1920, Frank Finkel made statements that he was a (lone) survivor of Custer's Last Stand. His assertions have been both accepted and rejected by various individuals. If there was a U.S. Army survivor of the battle under Custer's command, that individual was Frank Finkel. Those who doubt Mr. Finkel's claims rely upon his reported death by the military, stating that every soldier was accounted for.

Those who support Mr.

Finkel's assertions believe that he enlisted under the name of George August Finckle and was a Sargent in C Company at the time of the battle. Mr. Finkel stated that both he and his horse were wounded early in the engagement and the horse carried his semi-conscious body from the field of battle. His story continues with a narrative of being nursed back to health by a good samaritan.

Mr. Finkel's story then asserts that when he attempted to return to the Army, he was given such a hassle that he gave up and moved on with his life as a civilian. He purportedly kept quiet about his army service for 44 years. Why would he keep this information secret?

I suspect that his story is not completely accurate, but that he was a lone white survivor of the fight. I believe he used an alias to enlist. Using the name of August and a birthplace of Berlin would give him the prestige of German heritage and perhaps allow him to advance more readily up the

I also suspect he made a deliberate decision to leave the fight even though he may have been wounded. This would have contributed to his reluctance to discuss the situation for 44 years. The clincher for me was his knowledge of the location of potable water in the area. This was long before there were GPS systems or satellite maps available. I believe he was there.

Survivor of the Cambodian "Killing Fields" shares her story

Channy Chhi Laux was 13 years old when the Khmer Rouge (meaning Red Cambodia) took over her country, and her paternal grandfather was a refugee who fled Communist China to Cambodia. This writer read that the estimated number of people killed in this small country was one million, but she gave the estimate at two million. That is more than the estimated of one and a half million Armenians killed by the Turkish government during the Armenian genocide. And the Ottoman Empire/ Republic of Turkey was a much bigger country than the Cambodia with a population of 39 million, as compared to Cambodia's seven million.

The speaker mentioned that few people know about the Cambodian Genocide, and fewer people know that the Khmer Rouge were Communists. The Khmer Rouge were supported by Communist China, but the Khmer Rouge were more extreme in their ideology than their supporters. In her book Negotiating Socialism in Rural China, Dr. Xiaojia Hou mentioned that the Communist leaders hoped that the peasants would improve production by investing in things like farm equipment or farm animals. The Khmer Rouge believed that farm equipment was part of capitalism and that anything remotely similar to capitalism was evil; thus, the farm equipment was destroyed.

Channy's father was a successful businessman in Cambodia. He had knowledge of Chinese Communism, but decided not to flee Cambodia, thinking he could wait it out. Things couldn't possibly get worse in his estimation, but he was grievously wrong. The Khmer Rouge engaged in a policy of relocation, starvation and execution, using these acts to control the population.

Channy's family eventually marched from their city to the countryside on foot. When they arrived at a village, the locals were not happy to see them; not that the city people were not happy to be in that village either. The city people were allocated just one tablespoon of rice a day, whereas the village peasants allocated more rice for themselves. At first, the peasants were happy they were above the city people. But eventually, the peasants noticed that they were not as well off as before. They could not replace their clothes as often as in the past. Many people died of starvation or went hungry.

The Khmer Rouge engaged in radical social engineering by trying to replace mothers and fathers with the state. Children were encouraged to turn on their own parents, and their parents became scared of being denounced by their children. The speaker remembered one Khmer Rouge member (she called them "black uniforms") telling them

that they were to address him as "father."

The Khmer Rouge made all sorts of detailed laws, such as women not being allowed to have long hair. Before the Khmer Rouge took over, Channy already had short hair. During the four years that the Khmer Rouge ruled the country, her hair never grew long. She attributed that to malnutrition. She had the "satisfaction" of not being subject to having her hair cut by the Khmer Rouge.

During her time of trial, there were times when Channy wanted to give up and die. But she thought of her mother, who she had been separated from; she said she did not want to die without seeing her mother again, sometimes dreaming of dying in her mother's arms. Thoughts of her mother gave her strength to continue living.

A memorable moment in the speech was the speaker's comment about her Chinese heritage making her a target of attack for Khmer Rouge. A Chinese Cambodian docent at the San Jose Chinese museum (CHCP) claimed the Khmer Rouge persecuted those who were not "pure" Khmer, such as Chinese immigrants to Cambodia. The speaker's "light" Chinese skin made her an object of attack. Despite the Communist rhetoric of "all men are brothers," the Khmer Rouge acted more like ethnic or racial supremacists.

Eventually, Channy, her mother, her sister and two brothers were able to escape and make it to the United States. Sadly, her father and younger brother never made it. The survivors began a new life in Nebraska, where Channy became a Nebraska Cornhusker's fan. She moved to Silicon Valley where she worked as an engineer in aerospace and biotech for thirty years. Her family now runs a business called Angkor Cambodian Food (http://www.angkor.com/), which manufactures Cambodian food products.

Channy Chhi Laux wrote a book about her experiences, entitled Short Hair Detention. This is a long book, which runs 574 pages. Those who wish to learn more about the author and her ordeal may wish to read this book. It is available through Amazon.com in paperback and Kindle e-book. It is also available through Barnes and Noble by Nook e-book.

Kung Fu class begins at Chinese Performing Arts of America

On the first day of a Kung Fu class hosted by Chinese Performing Arts of America, there was a free introductory class from 3:45 to 4:30. Unlike the San Jose Wing Chun School, this class began at a set time with a formal "bowing in" ceremony, where the students and teacher makes a greeting by putting their right hand against their left palm and pushing out. In contrast, students at the Wing Chun School came to the school at various times, seemingly at their leisure. The teacher of the Wing Chun School, Li Yang, explained that it was more like a family. Having briefly studied Judo and Aikido, the formal "bowing in" ritual of the Kung Fu class seemed a bit more to what this writer was used

Since this was 45 minute introductory class, only a limited amount of material could be covered. After bowing in, the teacher began with warming up exercises. Bruce Lee, in his book Tao of Jeet Kune Do, stressed the importance of warming up. He mentioned how athletes, such

as ballerinas, would take several minutes before progressing to their activity. After the warming up exercises, the teacher introduced the class to stances in Kung Fu. Along with the stances, he introduced punches. What this writer remembers is that the stance exercises involved punching and transitioning from one stance to another. The student would start with the horse stance, execute some punches, and then transition to the arrow stance, ending with a punch. The teacher made it easier for us students by mirror imaging the technique.

Yang also teaches Tai Chi, but since time was limited, he did not cover that art. The teacher sees value in both "external" martial arts (e.g. Shaolin Kung Fu) and "internal" martial arts (e.g. Tai Chi). Kung Fu grandmaster Adam Hsu, author of the book The Sword Polisher's Record, would see value in both "external" and "internal" martial arts. The late Tai Chi advocate Cheng Man Ching gave the impression in his book, T'ai Chi: The "Supreme Ultimate" Exercise for Health,

Sport, and Self-Defense, that Tai Chi was superior to other martial arts, or that Tai Chi is all you need. A practitioner of Northern Shaolin and Tai Chi, told this writer that Cheng Man Ching did not have a complete knowledge of Tai Chi, but was a good marketer. He laughed and said Cheng Man Ching made a lot of money. A lesson to be learned in all this is don't be gullible or beware of grandiose claims.

Since the class has just begun, the content of the class is not fixed or solely committed to "external" Kung Fu. If more people show up and wish to learn Tai Chi, the teacher would most likely be willing to change the direction of the class or possibly add a separate Tai Chi class. Currently, the class is held at the CPAA which is located in the Orchard Farm shopping center at the corner of Miller and Bollinger. The big landmark in that shopping center is the Safeway market. 

Have you ever stumbled into a conversation where everyone is speaking around this "techie" word - and even after you've broken in, it is difficult to understand the unfamiliar jargon and acronyms? Well, there's no need to sweat it. Let us teach you the meaning of some commonly used tech words:

5G

Last week, Qualcomm announced that they have succeeded in creating a key component for supporting 5G cellular devices. Multiple telecom providers like Sprint and AT&T also announced plans to build a 5G network in the near future.

So what is 5G?

5G, short for "fifth generation," is the next generation of mobile internet connectivity, offering faster speeds (speed > 1 Gbps) and more reliable connections on smartphones and other devices than ever before. Researchers are way ahead of this and are targeting to achieve speeds in the range of 10-20

5G is best understood in terms of its predecessors - 2G, 3G, and 4G. With the debut of 2G in the early 90's, wireless

phone technology expanded from a voice-based technology to one that supported text messaging. 3G carried data in addition to text messages and phone calls, and 4G LTE (Long-Term Evolution) enhanced those capabilities with greater speeds and reliability.

5G brings about more improvements, but it's also comprised of a suite of new technologies. A 5G technology "full duplex" helps boost the signal even further. Most current-gen cell towers and phones can't transmit and receive data at the same time, but full duplex phones can route incoming and outgoing signals simultaneously, potentially doubling bandwidth.

But 5G won't provide nearly as much coverage as 4G LTE, or even 3G. In many ways, it'll seem more like Wi-Fi than a cellular technology. Instead of beaming connectivity from tall cell towers, 5G transmitters will be positioned closer to the ground. This requires a lot of ground coverage hardware to insure you'll actually have a reliable signal.

Now how this does affects your life? Short range, or closer to ground, means that many mobile towers are to be installed close to each other for covering all small areas. It may be on every other building, otherwise you will not get coverage. Many towers will need lots of resources for maintenance, and this will give extra cost to mobile company. This cost will reflect in your monthly mobile bill and 5G Data Pack recharges. After paying the huge bill, you will still have to go near a window to get coverage from a tower installed on the top of next building.

While most carriers were initially promising a wide-spread roll out of 5G in 2020, this may get delayed more. It's not yet known how 5G networks will take over from existing networks, but again, much like the rollout of 4G, you may not be able to immediately connect to the new networks without upgrading your technology.

Train Depot Saved by a Ford

There is a lot of truth to this Sage title. When I was ten years old, my parents allowed me to buy a train ticket to Detroit, Michigan on the New York Central Railroad on Thanksgiving Day (1952). What is so ironic about that event is the place that I would spend four hours away from home that day. I took along one of my grade school friends who needed to vacate his house for the same reason, which was getting out from underfoot of the kitchen crew preparing the Thanksgiving turkey. Our magic train trip took about a half hour from start to stop over the fourteen mile journey between Wyandotte and "the big Mo-Town of Detroit."

To experience the Michigan Central Station was a treat. The main floor was full of stores and restaurants. I remember having a couple of two dollar bills (common in those days) for buying something akin to lunch. We visited all the Christmas displays that were in place at the time but we didn't want to eat there. Instead we headed out though the big revolving doors of the main concourse. Just a side note here: by Thanksgiving Day, we would see the first snow flurries of winter so we were bundled up for the sub 30 degree weather at that time. Anyway, it was off across the street to "Walla," a White Castle Hamburger place. Oh my! At two for twenty-five cents, I would spend a dollar for a great lunch plus another twenty five cents for a big vanilla milk


shake. Oh yes, a big bag of salted fries was part of the banquet. We went back to the MC Station and did our Christmas shopping for moms and dads. That extra two bucks went a long way in those days. With our binge over and our pockets empty, we then boarded the afternoon train for home. This event went on for five years until we grew up and out of it, only to find the joy of girls. Trains didn't smile and giggle and get warm and cozy, and two bucks didn't go very far anymore.

As life went on for me, I never lost interest in the MC Station. Sadly, it became one of those symbols of decay of the bankrupt Motor City. Its massive edifice of 500,000 square feet and 18-story height a dark profile on the West Detroit skyline, abandoned; its thousands of windows broken out, stripped of its plumbing, decaying marble walls and floors, chandeliers and art work - sad. The last Amtrak train had pulled out in 1988 and all the services went with it. Its new tenants were homeless squatters, dope dealers and malcontents who picked through the ruble looking for something of value. To that end, the building was surrounded by cyclone fencing and razor wire, with mountains of trash and weeds. No senior citizen that served tens of thousands of travelers every day deserved that kind of reward for its service to the country, especially as the transportation center for numerous railroads of note and

the hub for the automotive center of the world.

Spring forward to just a few days ago, June 12th, with headline stories that the Ford Family and motor company had purchased the 105 year old building and presented plans of turning the 230 foot tall structure into a new Detroit campus for Ford's driverless car research facility. The company is also planning to spend one billion dollars on the restoration, updating and repurposing the historic building in order to place 5,000 employees with new jobs. A great deal of money was spent on the facade of the building along with the replacement of over one thousand windows with aluminum frames and cleaning up of the general area. On Tuesday, June 12th a press conference was held that was attended by over a thousand interested people from the Detroit Chamber of Commerce and other communities. This may be the kick start that Detroit needs to get the Motor City back on its wheels. I swear that I heard the sounds of Johnny Cash singing "I Hear the Train A-coming" and the "Wabash Cannon Ball." Maybe Amtrak will return with "High Speed Rail Service" to Chicago, St. Louis, Omaha and New York City. The scheduled opening is 2022, but I can remember what it was really like back in 1952. The building may change, but my memories won't.

On the Fly

Do we plate them? Is the flight on their paper? Travel Agents may still have this kind of discussion among themselves, but for outsiders to the travel industry, you won't have a clue what I am talking about, so here's an On The Fly history lesson...

Before they days of e-tickets (yes they did exist) your tickets were printed on a special kind of paper which was carbonated so it could write out several flights with one coupon for each flight but if you were the issuing agent you had to lean heavily on the paper with your pen to make sure it came through to last page in the min-booklet. Thus we had the paper ticket.

Airline validation plates were used to validate passenger ticket and other travel documents by a travel agency or other ticketing agency by placing them in an embosser and running the ticket over a validation plate.

These tickets were totally blank and before a travel agent, who had an agreement with the airline, could issue them, they had to be in possession of ticket validation metal plates which would be the airlines seal of approval on the paper ticket.

Without that seal, the ticket was worthless. If an airline withdrew agreement with an agency to issue tickets on the airline's behalf, the would to return these validation

If you think of how you used to use your credit card before contactless payment and PINs came in, it was a similar system whereby a retailer would produce a credit card blank voucher which would have the sale details on it and then they would swipe their merchant details on to the voucher and you would sign it.

So the term "paper" means an actual printed from every airline is actually issuing the flights and has the fare filed with the Global Distribution Systems (GDS) and its internal system. The "plates" were the devices that put the official airline seal on the ticket.

These were the days when the earliest you could check in was on arrival at the airport. You handed your paper ticket over at the check in counter and received a boarding pass, which sometimes would also have the ticket attached

In some cases, the seat assignment system was so basic they would peel off seat numbers from a sticky label aircraft seat plan and put it on your boarding

Now the airlines get you to do everything for them with your e-ticket and your electronic boarding pass on your Smartphone. Aren't they clever?

They have just saved themselves all the printing costs, but more importantly put you in control of your

Now you can do all these things online. But it is strange - despite e-ticketing and electronic boarding passes, I really prefer to have a bit of paper in my


